6:25 pm: Financial Report for 2016 by Treasurer: In the absence of Treasurer Mohit, Jay gave the informal report: revenues for the year reached \$195K, a more than 20% increase over the previous year due to increase in Learn To Windsurf and Kids Camp enrollment, with higher level instruction and volunteer participation, and good weather. New LTW gear purchases were up; half the increase in revenue will go into our bottom line, with a focus on major clubhouse upgrading for 2017.

Andrée presented several volunteer sign-up sheets for members to sign indicating what areas they could and would like to contribute to the operation of the club in 2017. She outlined the role of volunteers and the process of describing specific duties in several areas which need to be set and assigned.

Jay briefly outlined the success of the LTW and Camp this year and plans to expand this major club activity in 2017.

John pointed out that in his view the club has reached a new higher level of operation as directors and key volunteers not on the board gain experience; as well as heightened expertise in LTW and youth training and coaching suggests the potential of several full-time instructors raising the value of TWC for City Parks as a youth and adult recreation and high performance site – at no cost to the City, in return for the privilege of occupying the beach property. John also mentioned the fact that the club has reached storage capacity, meaning that the SUP component if it is to expand as expected, will need to find alternate site (while SUPs will remain a feature of TWC).
